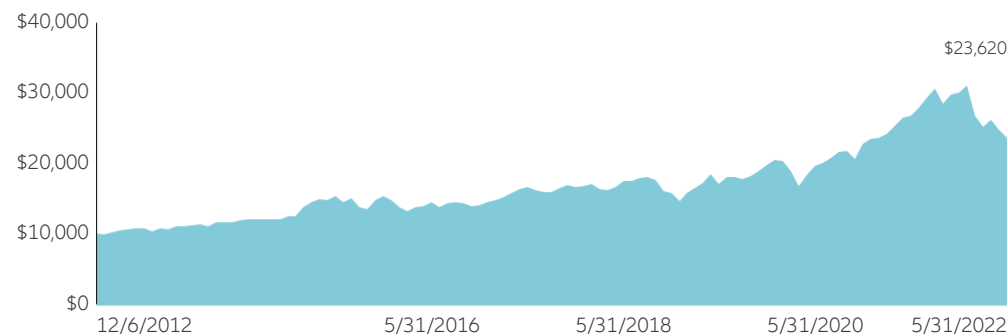
Fund highlights
