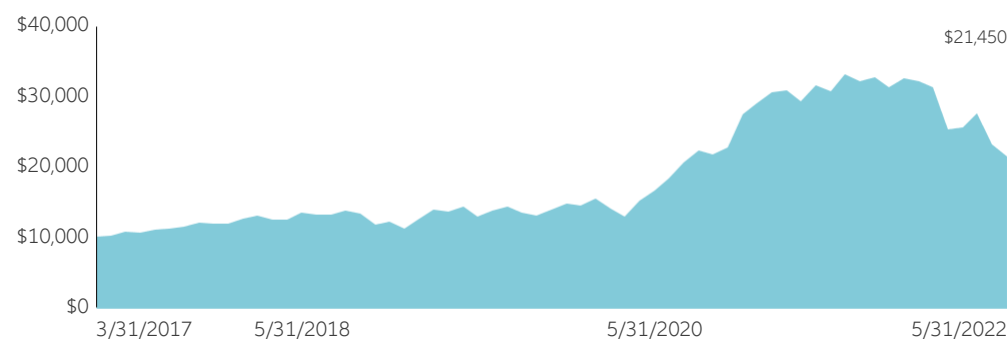
Fund highlights

- **Investing in the largest driver of innovation:** The advances brought by Artificial Intelligence are causing a wave of disruption across virtually every industry group that could dramatically alter operating efficiency and profit structures. The Fund seeks to attain long-term capital growth by investing in the global equity markets of companies whose businesses will promote or benefit from the evolution of Artificial Intelligence.
- **Bottom-up alpha generation:** We believe deep fundamental analysis is key to understanding the companies best positioned to achieve technological leadership in the expansion of Artificial Intelligence. Compared with the broad MSCI World Information Technology universe, which tracks large and mid-cap technology stocks in developed markets, the Fund is able to invest in what we believe are forward-thinking companies outside of the index that are developing or leveraging AI technology.
- **Managed by an expert team closely connected to Silicon Valley:** The investment team has decades of experience investing through periods of structural change, extensive relationships across Silicon Valley and dedicated global resources. We believe we can leverage that expertise to deliver compelling returns for investors in the strategy.
