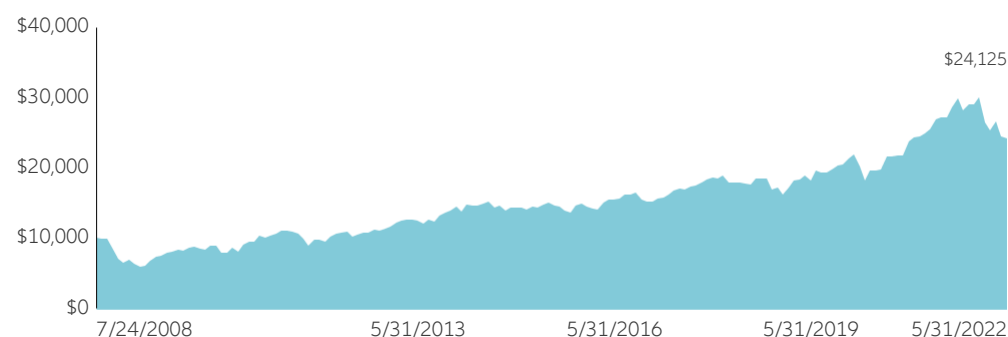
Fund highlights

- **Environmental expertise and global reach:** Allianz Global Investors has a team of analysts experienced in environmental, social and corporate-governance research. The Fund can also tap the firm's proprietary Grassroots® Research platform, which gathers on-the-ground market intelligence.
