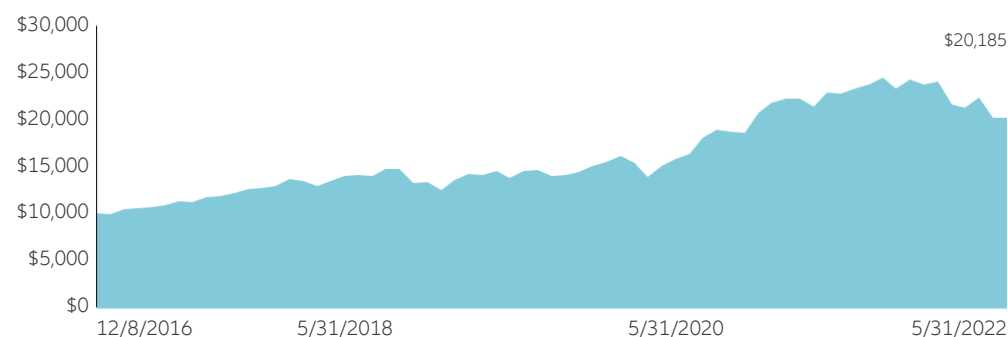
Fund highlights
