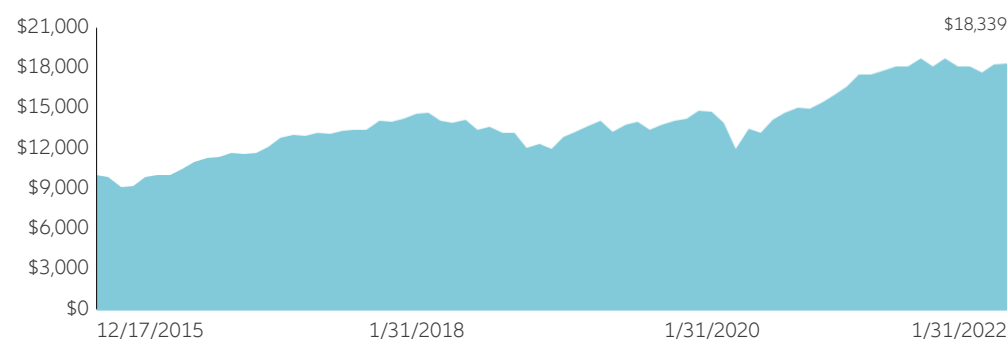
Fund highlights
